SPECIFICATIONS FOR HYDRAULIC DRIVEN FLAIL MOWER

General:

The overall scope of these specifications is to describe a hydraulic driven, skid steer mounted flail mower. The unit shall be the manufacturers latest production model and be covered by manufacturers standard warranty. The unit must also meet or exceed all Federal and State OSHA and ANSI regulations for this type of equipment in force at the time of delivery. The unit shall be delivered to the Agency as a complete working unit with all accessories mounted and functional.

The following make and model is to be considered acceptable for this bid.

2. Drive
 - A. Hydrostatic Drive
 - B. To include hydraulic hoses with quick couplings (Note: Exact style quick connect hose couplings to be determined with Agency Representative)
 - C. 21 GPM minimum flow requirement
 - D. 3 grove banded belt with spring loaded belt tensioner.
 - E. Direct coupled hydraulic motor to belt pulley.
 - F. 2100 mower RPM
3. Body/Frame
 - A. 10 gauge steel body
 - B. Replaceable, adjustable ski shoes
 - C. Heavy duty steel frame
 - D. To include all manufacturers standard safety shields and guards
4. Capacity
 - A. Ability to cut ¾” brush and very tall weeds/vegetation
